# Healing Courtyards

## a New Initiative



**T**he Dominican Hospital Foundation has launched a new initiative with preliminary plans for Healing Courtyards throughout the hospital. The concept of the Healing Courtyard is rooted in our commitment to nourish the physical, emotional, mental and spiritual needs of patients, their families, and staff through a healing environment. The latest research-based approach to design demonstrates that gardens and planted alcoves can help reduce pain and stress, and prove therapeutic.

Various studies of healthy people have proven that just three to five minutes spent looking at views dominated by trees, flowers or water induces measurable physiological changes in blood pressure, muscle tension, or heart and brain electrical activity. In multiple surveys, patients who had an opportunity to gaze at a garden setting needed fewer doses of strong pain medicine, had fewer postsurgical complications, and were less anxious.



A master plan is underway that will include five areas to be redesigned as Healing Courtyards as funds are raised for that purpose. The areas include:

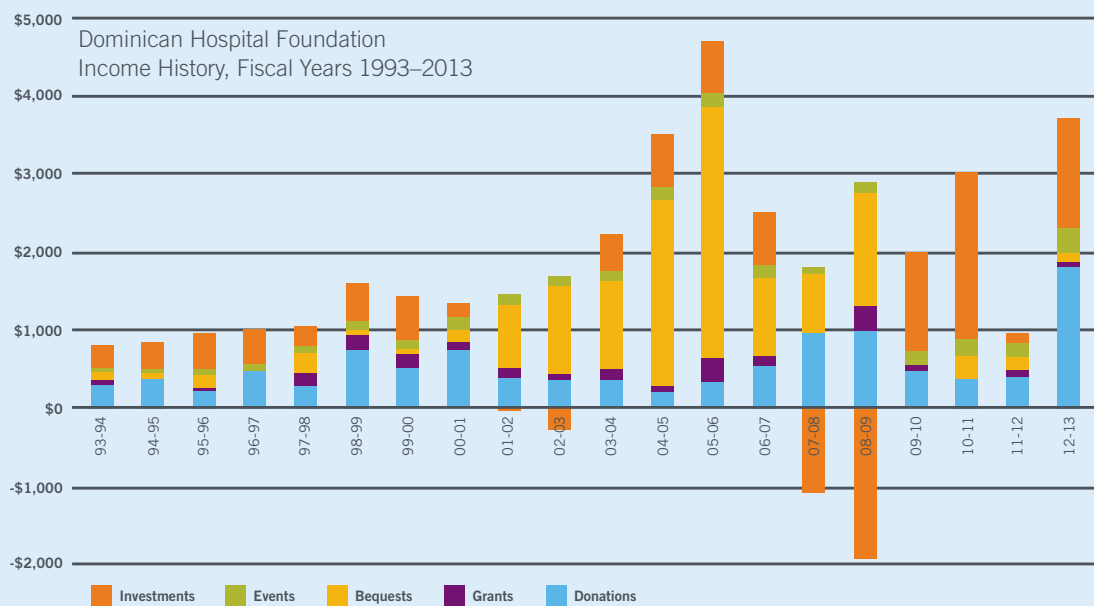
- **Main Entrance**
- **Courtyards A West of Entry, B NICU & C Northwest Courtyard**
- **Surgery Waiting Room Expansion & Courtyard**

# Triple Impact Gift Supports Neurosurgery Program

**T**he Dominican Hospital Foundation is the grateful beneficiary of a recent \$250,000 gift from Don & Ida Mungai. Don is a former Foundation board member and Ida has benefitted from our Acute Rehabilitation Unit and therapy program.

According to Don, “Dominican Hospital has always been one of our favorite charities. When we recently came into a position to give more, Dominican Hospital was in the forefront of our minds. We want to help Dominican Hospital be the best possible hospital for local people.” Ida shared with us that, “Dominican Hospital helps the whole community. I have very much appreciated the care of the nurses and doctors at Dominican.”

Don and Ida were both born in Santa Cruz to parents who were brussel sprout farmers. They met as classmates at Santa Cruz High and Don went on to graduate from Stanford University and Ida from San Jose State University. In 1954, two weeks after graduation, they were married at Holy Cross Church. Ida then joined Don in Tachikawa, Japan where he was stationed as a 2nd Lieutenant and Ida was a teacher. When they returned, Don went to work for John Battistini, working there for 40 years, eventually buying the insurance business which became the largest independent insurance agency in northern Santa Cruz County.

Ida taught fourth grade at Grant School, having a magnetic affection for children.



This system significantly increases the accuracy and safety of spine and brain surgeries. Right now only a few hospitals have this technology. We are really excited to bring this state-of-the-art system to Dominican Hospital,” says Ciara Harraher, MD, Medical Director of Neurosurgery at Dominican and Clinical Assistant Professor of Neurosurgery at Stanford.

The Mungai’s have three daughters and five wonderful grandchildren.

The gift has a triple impact for the donor, the Foundation and the Hospital. For the donors, this gift provides a legacy opportunity, and the dining room in the Acute Rehabilitation Center will be named in their honor.

For the Foundation, the funds provide a match for a \$500,000 challenge grant from the Monterey Peninsula Foundation. The gift completes the Foundation’s matching gift obligation and allows the funds to be released. The gift also helps to set a new level of giving to the Foundation.

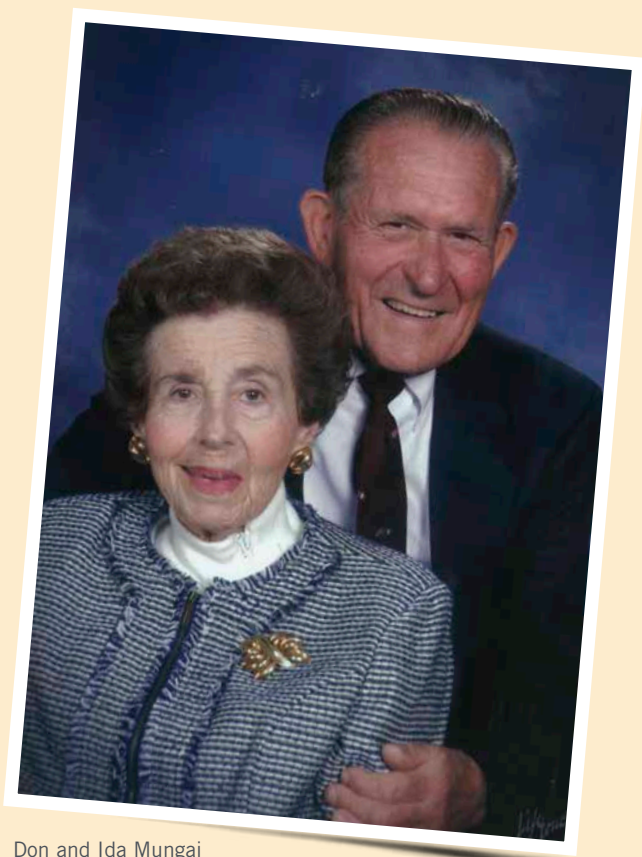

For the hospital, the gift will be used to help purchase an O-Arm imaging system and Stealth Navigation System for neurosurgery. This is a complete multi-dimensional surgical imaging system, used for spine

and brain surgeries. The O-Arm also serves as a mobile CT Scan that will be used on our highest acuity patient that reside in Dominican’s Intensive Care Unit.

In September of 2011, Dominican Hospital entered a Neurosurgery partnership with Stanford Hospital and has already experienced a 9% growth rate in this area. We are the only hospital in our region providing this level of neurosurgery. Patients recover from neurosurgery in our Acute Rehabilitation Unit and the O-Arm is part of our Acute Rehabilitation Unit Initiative. This is one of four major initiatives identified by the hospital and the foundation for private support.

This triple impact gift is another step in Dominican Hospital Foundation’s strategy to clearly identify needs, focus on obtaining major gifts and, as a result, dramatically improve patient care. We are working together, to bring the best possible medical care to our community.

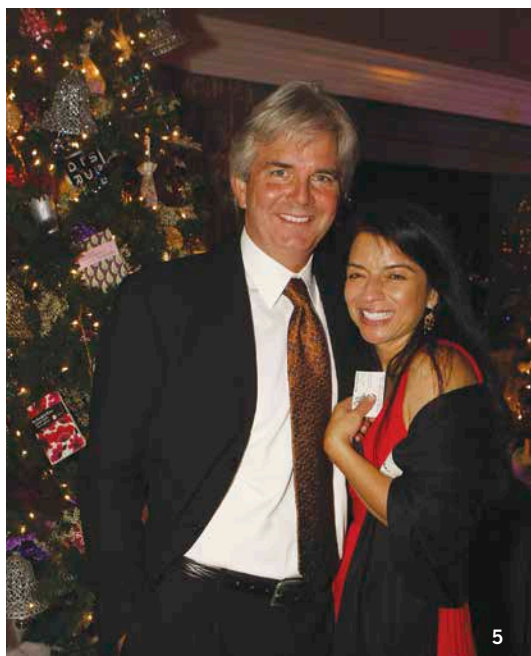
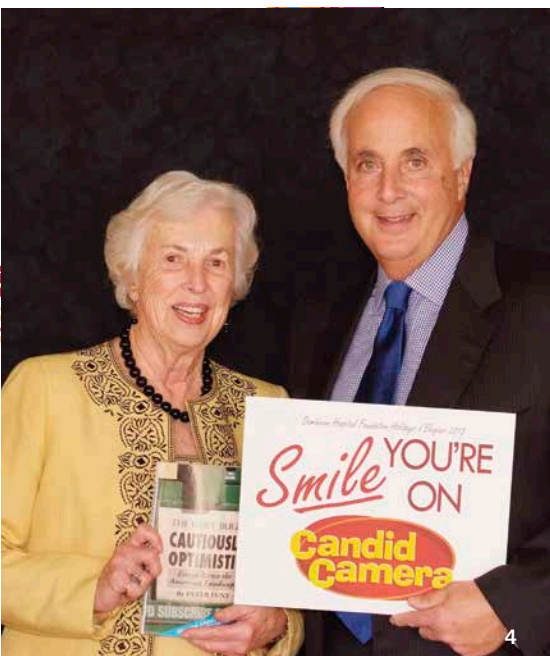
As always, many of you have participated at the events. Together, we overwhelmingly exceeded our goal and the proceeds of last
